## SPONSORED SCHOOL PROFESSIONAL DEVELOPMENT PROCESS

Consistent with its Board adopted policy, the District adopts the following process for sharing and/or offering information about professional development opportunities to its Sponsored Schools.

#### 1. Annual Overview of Professional Development Opportunities

Each year, the District may provide Sponsored Schools with a list of professional development opportunities. This list is intended as an overview of professional development opportunities that will guide Sponsored Schools in self-identifying professional development opportunities.

#### 2. Professional Development Regarding the Role of the Sponsor.

Each year, the District shall offer training to assist Sponsored Schools in understanding the roles and responsibilities of the sponsor and the school. This training shall complement the guidance provided on the Role of the Sponsor

### 3. Professional Development Regarding Legal and Policy Update.

Each year, the District shall offer training to assist Sponsored Schools in understanding the changes in rule, law, and policy that impact community school operations.

### 4. Professional Development Opportunities Specific to Community Schools

Each year, the District will share at least one professional development opportunity to Sponsored Schools that is specific to community schools. Such opportunities may also include the District's Annual Legal Update Training and Role of the Sponsor Training.

# 5. Professional Development Based on Needs Assessment

If the District completes a Needs Assessment that determines the professional development needs of its Sponsored Schools, the District may share or offer specific, targeted professional development opportunities that are based on determinations made in the Need Assessment.
